### Minutes of July 03, 2014 Annual Meeting of Landowners & Supervisors of The Central Charlotte County Drainage District

The Annual Meeting of Landowners & Supervisors of The Central Charlotte County Drainage District was held on Thursday, July 3, 2014, at the Charlotte County Public Works Building, 7000 Florida Street, Punta Gorda, Florida 33950. The President of the District, Mr. Robert "Bucky" McQueen, called the Meeting to order at 2:00 p.m. Roll was taken. All Supervisors of the District, being Clause H. Collier, David Anthony, and Robert "Bucky" McQueen were present at the meeting, with Mr. David Anthony participating via telephone. The said Supervisors also constituted the landowner representatives who were present at the Meeting. Also in attendance were Jeanette Fowler, Secretary/Treasurer of the District, and Edward L. Wotitzky, Esq., attorney for the District.

Proof of the proper posting and publishing of the Notice of Meeting was then established. The Notice of Meeting was published in the Charlotte Sun on June 19 and June 26, 2014. Attached to these Minutes is the publisher's Affidavit of Publication which includes a copy of the Notice of the Annual Meeting.

The Landowners and Supervisors then considered the Minutes of the June 20, 2013 Annual Meeting. After review, and on Motion duly made, seconded and unanimously carried, the Minutes were approved as submitted.

The Landowners then proceeded to elect one (1) Supervisor. The attorney for the District advised the term of Claude H. Collier would expire on September 30, 2014, and that the Landowners were required to elect an individual to serve in that term.

The floor was open for nominations, and Mr. Claude H. Collier was nominated to serve an additional three (3) year term. Mr. Collier advised he would so serve. There were no further nominations, and on motion duly made, seconded and unanimously carried, Mr. Collier was elected to serve as a Supervisor for a three (3) year term commencing October 1, 2014. As a result of the election, the following individuals constitute the Supervisors of the District for the noted terms:

The Supervisors then proceeded to elect officers for terms commencing on October 1, 2014. After discussion, and on motion duly made by Claude H. Collier, seconded by David Anthony, and unanimously carried, the following individuals were elected to the noted offices:

President - Robert "Bucky" McQueen

Vice President - David Anthony Secretary/Treasurer - David Anthony Jeanette Fowler

The Financial Statements for fiscal year ending September 30, 2013 were then reviewed. Attached to these Minutes is a copy of the Financial Statement showing income and expenses for fiscal year ending September 30, 2013. Also attached to these Minutes is a bank statement from Bank of America showing the Account Summary as of May 30, 2014, and a Revenues and Expenditure Report for fiscal year 2013. Mrs. Fowler reviewed the Financial Statements and other material with the Supervisors. After review and discussion, and on motion duly made by Claude H. Collier, seconded by David Anthony, and unanimously carried, the Financial Statements were approved as presented.

The Supervisors then considered the Budget for fiscal year commencing October 1, 2014. The proposed Budget was presented by Jeanette Fowler who indicated that pursuant to the proposed Budget, the acreage assessment would remain unchanged at \$14.00 per acre. A copy of the proposed Budget is attached to these Minutes. After discussion, and on motion duly made by David Anthony, seconded by Claude H. Collier, and unanimously carried, it was

RESOLVED, that the proposed Budget, a copy of which is attached hereto, for fiscal year commending October 1, 2014, be, and the same is hereby approved and adopted. It was further

RESOLVED, that assessments be levied at the rate of \$14.00 per acre for fiscal year beginning October 1, 2014.

The Supervisors then considered maintenance of the ditches and canals in the District for the upcoming fiscal year. Mr. McQueen reported that the County had cleaned the drainage ditch along Westminster Road and Grove Boulevard. He noted that the herbicidal spraying conducted by Lake Doctors had been completed during the last fiscal year at a cost of approximately \$6,000.00.

After further consideration and discussion, it was determined to authorize the expenditure of up to \$7,000.00 for cleaning approximately six (6) miles of District canals and ditches. On motion duly made, seconded and unanimously carried, it was

RESOLVED, that the expenditure of \$7,000.00 for canal and ditch maintenance be, and the same is hereby approved, and that Mr. McQueen, as President of the District, is empowered and authorized to accept a proposal on behalf of the District for aquatic control work required in connection with ditch and canal maintenance.

Mr. McQueen noted that requests for proposals would be prepared and provided to interested parties, including Lake Doctor which had performed the work in the last fiscal year.

There being no further business before the Landowners and Supervisors of The Central Charlotte County Drainage District, the Meeting was, on motion duly made, seconded and unanimously carried, adjourned.


