**ORDER EXTENDING CORPORATE EXISTENCE OF THE CENTRAL CHARLOTTE COUNTY DRAINAGE DISTRICT**

THIS CAUSE, having been heard on the Motion of the Board of Supervisors of The Central Charlotte County Drainage District to extend the corporate existence of the said District for a period of 30 years from January 6, 1996; and the Court finding that The Central Charlotte County Drainage District was created by that certain Order entered in the above-styled cause on January 6, 1966, which Order created and established a water-control district pursuant to the requirements of Chapter 298 of the Florida Statutes with respect to property located in Township 41 South, Range 23 East, Charlotte County, Florida; and the Court being otherwise duly and fully advised in the premises, and finding that the Court has jurisdiction to extend the corporate existence of the District pursuant to Chapter 298 of the Florida Statutes, it is, therefore,

ORDERED and ADJUDGED that The Central Charlotte County Drainage District shall be and shall continue to be a public corporation of this State for an extended term of 30 years commencing on January 6, 1996, and continuing until January 5, 2026. It is further

ORDERED and ADJUDGED that the Clerk of Court shall retain this as an active Court file during the pendency of the corporate existence of the Central Charlotte County Drainage District.
